I have never been convicted or found NGRI of any sex offense prohibiting firearm ownership.

For any felony convictions or NGRI’s, I have been in the community for five (5) or more consecutive years without being convicted or found NGRI of any felony, gross misdemeanor, or misdemeanor crimes.

For any non-felony convictions or NGRI’s, I have been in the community for three (3) or more consecutive years without being convicted or found NGRI of any felony, gross misdemeanor, or misdemeanor crimes.

I am not under a court restraining order, injunction or other order, either civil or criminal, which prohibits me from possessing a firearm.
